Requirements for change of name on Australian adult Passports

1. Completed overseas application form/s (PC8 - 5 pages), available on www.passports.gov.au

2. Two recent passport photos. One photo must be **endorsed by a guarantor** Please consider providing extra unsigned photos that will be returned if unused.

3. Your current original Australian passport.

4. Your original official Australian Birth Certificate (Commemorative Australian birth certificates cannot be accepted), **OR** If born <u>outside</u> Australia, the following original documents must be presented;

Citizenship certificate

> Foreign birth certificate that shows both parents names with English translation, if applicable.

Note; if the citizenship certificate or the birth certificate does not show your city of birth, you must provide further supporting documents to prove that.

5. One of the following valid documents;

Australian/foreign driver's license > Foreign residency ID card > Australian Proof of ID card

6. And, one of the following valid documents;

Medicare card
Credit/Bank card
Foreign passport
National Insurance card
More information on the combination can be found page5 of the application form.

7. A proof of address in the country of residence, such as, the national address (for residents in Saudi), tenancy agreement, letter from the landlord, utility bill etc. The document must be in English.

8. If you were born in Australia **but** married overseas, your foreign marriage certificate will not be accepted to support a family name change; in these circumstances, you must apply to an Australian RBDM for a change of name certificate.

9. If you were <u>born and live overseas</u> and cannot meet Australian RBDM residency requirements to register a name change, you may use the name in a foreign name change or marriage certificate, provided this was issued after you obtained Australian citizenship, and has been properly legalised or apostilled by the issuing government. If the documents are not in English, you must provide a full English translation prepared by an approved translation service.

10. In the case of foreign issued change of name certificate, the applicant must also submit:

- <u>B11 form</u> confirming the applicant's inability to change his/her name with an Australian RBDM and other documentation to confirm residency overseas (eg. tenancy agreement, utility accounts).
- Original foreign name change certificate issued by the relevant foreign government authority that clearly establishes the identity of the applicant and the link between the two names; and
- > The foreign name change certificate must be legalised by the issuing government.

Important notes:

- All documents MUST be originals. If the interview is during passports visits to Oman and Bahrain please provide black and white copies too.
- Passport application page should be clear and show all page parts/information (application with missing information/part/s will be rejected)
- If you changed or wish to change your signature on the new passport, please complete <u>B11 form</u> and declare the change (only applicable for children 10 years of age and above).
- Final acceptance of photos provided will be determined after scanning. New photos would then be required to be mailed to the embassy.
- Sending the new passport will incur charges which should be paid by client upon delivery.
- Minors between 16 and 18 year-old, will have a full validity passport. In addition to that, they must attend an interview along with one of the parents
